In terms of their issuance, Platex may choose to convert or redeem these FCDs. However, PVP Ventures Limited and Platex has agreed to extend these FCDs redemption/conversion anytime upto March 31, 2016 which was taken on record by the Board at its Meeting held on March 18, 2013. In future if Platex chooses to convert, in terms of the Scheme, it will get further 65,14,215 equity shares of the Company.
