<b>Note:</b> These 13,289 Fully Convertible Debentures of Rs.1,00,000/- each (FCDs) were issued and allotted to Platex Limited, the Promoter group company ("Platex") in accordance with Clause 4.1.2(ii) read with 4.2.1 of the Scheme of Amalgamation between erstwhile PVP Ventures Private Limited and the Company, which was sanctioned by the Hon'ble High Court of Madras at Chennai vide its Order dated April 25, 2008 in the Company petition No. 90 of 2008 (The Scheme). In terms of their issuance, Platex may choose to convert or redeem these FCDs. However, PVP Ventures Limited and Platex has agreed to extend these FCDs redemption/conversion anytime upto March 31, 2016 which was taken on record by the Board at its Meeting held on March 18, 2013. In future if Platex chooses to convert, in terms of the Scheme, it will get further 65,14,215 equity shares of the Company. However, Platex Limited has transferred the aforementioned 13,289 FCDs to India Investment II PTE Limited on September 04, 2014 which was approved by the Board of Directors at its Meeting held on September 04, 2014.
